Guarantor hereby consents to any of the following actions taken by the Seller with respect to Liabilities, without notice to or the approval of Guarantor; (1) the incurring of any Liabilities; (2) the extension of the time of payment of any the Liabilities in whole or in part; (3) the modification of any provision relating to any of the liabilities; and (4) the sale, surrender, exchange or modification of any security which Seller may hold at any time for payment of any of the Liabilities. If more than one person sign this Guaranty Agreement, each shall be liable for the entire amount of the guaranteed obligations, jointly and severally. Guarantor, recognizing that individual credit history may be necessary in the evaluation of this personal Guaranty, hereby consent to and authorized Seller to use consumer credit report on Guarantor, from time to time, as Seller may deem appropriate at Seller's discretion for use in Seller's credit evaluation.
